



SOUNDPACK LICENSE AGREEMENT

CLICK-WRAP LICENSE AGREEMENTS

By purchasing, downloading, accessing, or using this soundpack, Licensee expressly acknowledges that they have read, understood, and agree to be bound by the terms of this License Agreement.

Soundpack Usage License

Effective upon purchase

IMPORTANT: by downloading, accessing, or using the audio files provided by Mixbros (“Sounds”), you (“User”) agree to be bound by the terms of this Agreement.

1. Grant of License

Mixbros (“Licensor”) grants User a non-exclusive, non-transferable, royalty-free license to use the Sounds solely as incorporated into original musical compositions and audio-visual works.

All rights not expressly granted are reserved by Licensor.

2. Permitted Uses

User may:

- use the Sounds in original music productions
- use the Sounds in commercial releases
- monetize music containing the Sounds
- use the Sounds in films, videos, games, podcasts, and other media
- publicly perform and distribute works containing the Sounds

No royalties are owed to Licensor for such permitted uses.

3. Prohibited Uses

User may NOT:

- resell, sublicense, share, lend, or redistribute the Sounds as standalone files
- include the Sounds in any competing sample pack, loop kit, VST instrument, or sound library
- make the Sounds available for download by third parties except as embedded in a musical work
- register the Sounds alone in YouTube Content ID or similar fingerprinting systems
- use the Sounds to train artificial intelligence or machine learning systems
- claim ownership of the Sounds or any portion thereof

4. Ownership and Reservation of Rights

All Sounds remain the sole and exclusive property of Mixbros. Nothing in this Agreement transfers any copyright or ownership interest to User. This Agreement grants usage rights only. Licensor expressly reserves the unrestricted right to:

- use the Sounds
- license the Sounds
- sell the Sounds
- include the Sounds in future products
- distribute the Sounds in any manner

5. Content ID and Platform Responsibility

User is responsible for ensuring that their use of the Sounds within musical works does not create false Content ID or copyright conflicts.

User shall not assert ownership claims over the Sounds themselves.

6. Indemnification

User agrees to indemnify, defend, and hold harmless Mixbros from and against any and all claims, damages, liabilities, costs, and expenses (including reasonable attorneys' fees) arising out of or related to User's use of the Sounds.

7. Termination

This license automatically terminates upon breach of any term of this Agreement.

Upon termination, User must cease distribution of any standalone Sounds in their possession.

8. Miscellaneous

This Agreement constitutes the entire understanding between the parties and supersedes any prior understandings relating to the Sounds.

If any provision is held unenforceable, the remaining provisions shall remain in full force and effect.

This Agreement shall be governed by the laws of England and Wales.
